Campaign Gift Plans

There are many ways to make a gift to the “Fixing God’s House” Campaign. Many donors may feel they can give a larger gift by extending their payments.

Pledges are the financial lifeblood of the campaign. They provide the donor the opportunity to make a greater commitment to the project than a one-time cash gift by making payments over a five-year period of time. An initial payment on a pledge is very beneficial, since it provides immediate cash to begin our many maintenance projects.
